## SYSTEMATIZATION AND CODIFICATION OF LEGISLATION: A CONCEPTUAL DIMENSION

**Key words:** codification, systematization, administrative legislation, world standards, normative legal acts.

The article is devoted to the issues of systematization and codification of legislation, since they are a form of law-making, and their main purpose is to ensure the most complete legal regulation of a certain sphere of public relations by adopting logically perfect normative acts of a complex and generalizing nature. Based on a critical analysis of the norms of post-Soviet jurisprudence, the author offers a modern understanding of the essence and role of administrative legislation, taking into account its consistency with European standards. The main problematic issues, inconsistencies and legal conflicts in this direction are highlighted.

Attention is focused on the feasibility of distinguishing the norms of substantive and procedural law according to the theory of law and taking into account the practical experience of public authorities, which is currently not implemented in the administrative Code. It is determined that effective legal support of administrative reform is impossible without further systematization of administrative legislation, which should be implemented in the form of codification of its norms. Suggestions are given for optimizing the process of standardization and codification of Ukrainian legislation.

It is theoretically proved that bringing Ukrainian legislation into line with international standards is possible only if comprehensive and coordinated actions are taken. The gradual implementation of the proposed program does not exclude the possibility of implementing those steps that are envisaged at later stages, if this optimizes the entire process of unification, standardization and codification of Ukrainian legislation. However, it is mandatory to constantly monitor the results of implemented innovations and, if necessary, adjust them.

The openness of this process should be ensured by a broad discussion with the public, the scientific community and the popularization of legislative actions of the government among the population. Improving the legislation of Ukraine in accordance with the concept of mutual responsibility of citizens and the state will contribute to the further development of Ukrainian law and society.
