DEVELOPMENT OF NATIONAL LEGISLATION IN THE SPHERE OF SOCIAL PROTECTION OF POPULATION

The state guarantees social protection provided by the Constitution of Ukraine, including "Citizens have the right to social security, including the right to security in cases of complete, partial or temporary disability, widowhood, unemployment circumstances beyond their control, as well as old age and other cases provided for by law". The right to social protection is guaranteed by obligatory state social insurance at the expense of insurance contributions of citizens, enterprises, institutions and organizations, as well as budgetary and other sources of social security; creating a network of public, communal and private institutions for the care of the disabled. The article analyzes the social legislation system in Ukraine, which is sufficiently extensive, including acts of general action and acts of special action that target certain categories and groups of socially vulnerable groups of the population. It was noted that there is a need for further improvement of legislation on the social protection of civilians who have been affected by fighting or armed conflict. The article analyzes the laws and by-laws of Ukraine, international documents (reports) that determine the directions of development social legislation in modern Ukraine. The purpose of this article is to determine the directions of development social legislation in modern Ukraine based on the analysis the social legislation system in Ukraine. It is established that further development of legislation requires amendments to the current social legislation of Ukraine, in particular, regarding the settlement of social protection issues for participants and persons affected by the war and military conflicts, their families in terms of status determination, benefits and benefits list - major issues of development of modern society and the state, and requires scientific justification and prediction the consequences of application. However, a number of regulations set procedure for providing targeted assistance to internally displaced persons.
