

UNDERSTANDING THE MAIN TERMS OF THE LAW OF UKRAINE "ON PREVENTION OF CORRUPTION"

Key words: *corruption, direct subordination, relatively permanent subordination, indirect legal dependence, cohabitation.*

The scientific article is devoted to the understanding of the main terms of the Law of Ukraine „on prevention of corruption“. The interpretation of such legal categories as „direct subordination“, „direct subordination“, „relatively permanent subordination“, „indirect legal dependence“, „cohabitation“ is given. Determining the content of the concept of „direct subordination“ is important for the correct application of article 27 of the Law on restricting the joint work of close persons. This concept should be distinguished from related concepts. Some laws define rules: the chief (Manager) is a person who has full administrative authority over subordinates, the power to interfere in the lawful activities of subordinates, to make decisions individually, to give (issue) orders and orders, to ensure their implementation and cancel them, to apply incentives and impose disciplinary penalties or to request this before a senior direct boss (Manager), to remove a subordinate from the performance of official duties in the event of a gross violation of official discipline, monitor the state of service discipline among subordinates and take measures to prevent the Commission of disciplinary offenses. All the heads (leaders) usually are direct, although there are exceptions, of below; any head (head), which the employee (officer, soldier, etc) is subordinate to the service (work) at least temporarily, if it is declared by the order, is considered a direct superior (head); direct heads (heads) are divided into immediate superiors (managers) and supervisors (managers) at the highest level; the direct chief (Manager) closest in position to the subordinate is the direct chief (Manager). All direct supervisors are direct, but not all direct supervisors are direct. In addition, there are indirect bosses (managers). The most detailed of their status is written out in the acts of military legislation.
