

TO THE DEFINITION OF THE ADMINISTRATIVE AND LEGAL MECHANISM FOR THE PREVENTION OF BULLYING IN UKRAINE

The article is devoted to defining the definition of an administrative and legal mechanism for preventing bullying in Ukraine. It is determined that the content of the category «mechanism of administrative and legal regulation» and «administrative and legal mechanism» are identical, however, given the specifics of the scope in which this study is conducted, attention is drawn to the fact that the most appropriate and optimal is use of the term «administrative and legal mechanism». Specified to date there is no unified vision for this category; each of the researchers individualized the concept, filling it with its own specific content. It is stated that the administrative and legal mechanism can be considered in a broad and narrow sense. In turn, in the broad sense of the administrative and legal mechanism is to understand the phenomenon by which the regulation of social relations by the rules of administrative law. The narrow meaning reveals, besides the above, the essence and purpose of such regulation. Based on the conducted research, it is concluded that under the administrative and legal mechanism of preventing bullying in Ukraine should be understood a complex phenomenon, which is at the same time a certain process and a set of legal methods and means regulated by the administrative and legal norms by which competent entities are empowered to carry out administrative and legal regulation of relations related to the implementation of actions aimed at preventing and counteracting bullying in Ukraine. It is found out that the features of the administrative and legal mechanism for preventing bullying in Ukraine include complexity; dynamism; systematic; integrity; legislative regularity; competence of authorized entities; goals and objectives.
