The article reveals that the world order: is a planetary global hierarchical system of international relations and relations between States or unions of States, which has received international legal consolidation and has a distribution of political roles at the planetary or regional levels; it is an eschatological, Messianic project, which is based on the idea of political and economic domination of a certain occult top of the financial oligarchy, based on an ideological and speculative-usurious revolution, which arose as a result of this new thinking; it has a multi-level, interdependent and mutually dependent hierarchical structure of States.

It is determined that one of the main goals of the New world order is the cosmopolitanization of mankind. The problems of building a modern monopolar world order lie in the claims of the United States to planetary hegemony, which after the collapse of the Soviet Union felt like the only superpower and are trying to establish their own world order of Imperial orientation. It is theoretically justified that in order to achieve its strategic goals, the United States forms centers of power in Europe, Asia and America, which should become a support for the establishment of a new monopolar world order, which are formed in a tangle of contradictions with the United States, because contradictions exist between continents and world regions with their geopolitical centers of power (such as Germany in Western Europe, Russia in Eastern Europe, Japan and China in Asia). One of the foreign economic factors in the development of Eastern Europe is the Islamic market, which is being formed under the leadership of Turkey. The attention that now is the most difficult problem in the geopolitical formation. It is argued that Ukraine is in a zone of political conflicts, and many of them are based on geopolitical factors that give grounds to assert the possibility of the emergence and development of terrorism in Ukraine on the basis of existing contradictions and clear interests of various geopolitical forces, both internal and external.
