## ACTS OF THE CONSTITUTIONAL COURT OF UKRAINE: SOME ASPECTS

The article examines some aspects of the reforming of the competence, internal organizational structure of the Constitutional Court of Ukraine, which affected the legal nature of the acts of the Constitutional Court of Ukraine. The system of acts of the Constitutional Court of Ukraine is analyzed, their features, procedure and guarantees of their implementation. According to the current legislation of Ukraine, acts of the Constitutional Court of Ukraine are decisions, conclusions, prescript, resolutions and protective orders. The attention is focused on changes in the current legislation as to the extension of the list of issues regarding which the Constitutional Court of Ukraine, and in particular its Grand Chamber, gives conclusions. In particular, the norm, which imposes on the Constitutional Court of Ukraine an extremely important exclusive right of preventive constitutional control as to the range of issues that are proposed for making an all-Ukrainian referendum on a people's initiative, is considered. It was noted on controversy of issue as to the verification of normative legal acts of the Verkhovna Rada of the Autonomous Republic of Crimea regarding accordance not only with the Constitution but also with the laws of Ukraine.

It is noted the importance of constitutional implementation of the provisions about the legal validity of decisions and conclusions of the Constitutional Court of Ukraine. A significant guarantee of the implementation of the decisions and observance of the conclusions of the Constitutional Court of Ukraine became the provision on liability for failure to comply with the acts of the Constitutional Court of Ukraine, in particular the criminal one.
