The article is devoted to the study of the legal activities of the legal support units of state bodies, in particular the bodies of the state tax service, taking into account a certain retrospect. The article stated that in the organization of the activities of any enterprise or organization there are always functional divisions that ensure the performance of statutory tasks and functions, and those that provide, which, in particular, include legal. The proposed work contains different definitions and understandings of the term "legal activity", that indicates the multiplicity of approaches to the definition of the considered category. The work proposes a structure of legal activity, which is formed by subjects, objects, legally significant actions and events. The analysis of practical activities in the bodies of the state tax service allows us to conclude that activities with the application of legal norms concern not only legal divisions, but all structural ones, including functional ones.
